#### **Tuition Fee**

#### **Non NRI Quota**

Amount of Tuition fee is as mentioned in PMET-2012 prospectus of Baba Farid University of Health Sciences, Faridkot and subsequent changes from time to time.

Note:-

1. The university registration/Examination and others fees will be extra as notified by the university from time to time.
2. Fee is to be deposited preferably through RTGS/Demand Draft in favour of Principal Adesh Institute of Medical Sciences and Research, Payable at Bathinda for MBBS

course/ Principal Adesh institute of Dental Sciences and Research, Payable at Bathinda for BDS course.

3. Each admitted candidate shall be required to furnish at the time of admission a Bank Guarantee / Surety bond (Appendices 5A/5B) for the amount equivalent to full course fee on yearly basis along with an undertaking in the form of affidavit duly sworn by the candidate himself and his parents and attested by an Executive Magistrate. **In case of Surety bond, Registry document of the Property to be produced in original at the time of admission along with certificate of valuation from the competent authority.**
4. If the candidate leaves the institute /shifted or migrates to some other institute, after last date of admission or before completion of the full course, including internship training, due to any reason whatsoever, the college security and the hostel security already paid shall stand forfeited. In addition, he will have to pay to the concerned institute all balance fees for the entire course.
5. University examination form will be sent to the university only after the payment of all dues and after getting No Dues certificate from the competent authority.

### **NRI Quota**

Amount of Tuition fee is as mentioned in PMET-2012 prospectus of Baba Farid University of Health Sciences, Faridkot and subsequent changes from time to time.

Mode of Payment is as under

1 <sup>st</sup> Instalment at the time of Admission	60% US\$
2 <sup>nd</sup> Instalment after one year of 1 <sup>st</sup> Instalment	20%US\$
3 <sup>rd</sup> Instalment after one year of 2 <sup>nd</sup> Instalment	20%US\$

**Note:- Entire tuition fee is payable in one instalment at the time of admission. In case a candidate opts for payment in instalments as above, he/she (parent in case of minor) will have to give bank guarantee (as per appendix 5A) for each instalment separately.**

**Note:** -NRI unfilled seats under special management quota will be filled up as per Govt of Punjab Corrigendum Notification no 5/3/08/3HBIII/1166 dated 19.03.2012 and as per interim order of H'ble Supreme Court of India vide CWP No 7052 of 2011 dated 19.07.2012

### **Refund of Tuition Fee**

Fee one paid shall not be refunded. In case any student leaves the institution due to any reason what so ever after closure of the admission process/ before completing the full course, fee for the entire course is payable by him/her.

### **Fee from Failed/ Detained Students**

A student failing/detained in any subject(s) in a university examination shall be required to pay, for each subject and each attempt, tuition fee @ of Rs 4000/- for students admitted against Non NRI seats or US \$ 400 or equivalent amount in INR for students admitted against NRI seats.

### **Hostel Charges**

All admitted candidates are required to stay in the hostel situated in the Adesh University Campus. All the rooms are special rooms with attached bathrooms and rooms coolers. Charges are Rs 24000/- per annum. Standby electricity backup is available round the clock.

### **Security deposit**

Security of Rs 25000/- or equivalent will be deposited at the time of admission. It is refundable without interest after adjustment if any, on the completion of the course (including compulsory one year rotatory internship training) after submitting the “No Dues Certificate” from the competent authority.

### **Mess Charges**

Mess charges of Rs 35000/- are payable in advance every year. This does not include canteen charges these charges are subject to revision from time to time.

#### **Note:-1.**

The hostel charges other than security deposit are provisional and to paid in two instalments. These charges are exclusive of electricity and other charges. Electric points for light, fan, cooler, computer and music system are provided. Charges for gadgets other than these are extra. Electricity charges are subject to revision from time to time.

#### **Note:-2**

The candidates will be required to submit an undertaking to the effect that they will pay all dues as amended from time to time as approved by the competent authority (Appendix 3)
